

# European Angel Investment Summit 2023 Startup Application Instructions

If you wish to be selected to pitch at EAIS 2023 taking place on 10-11 October in Brussels Belgium, please submit your investment project on the InvestEU Portal by 3 September 2023, following the instructions below:

Click "Add your project"



1. Log in\* or create a new profile\*\*, providing details about your organisation. Your organization may be based in any country, however, your project must be based in the European Union.
2. Upload documents establishing the company's legal entity (e.g. registration extract) and any other relevant documents (e.g. recent audited financial statements, activity reports) detailing the activity of the company.
3. Complete information about your "project". Here as well you can submit information about your startup in more detail. Please make sure to include details about the investment round you are raising. Instructions on what information to include for each question are given at this link:



4. Once you complete all 3 parts of the form (profile – organisation –project), you should receive an email confirmation indicating your unique reference number (format: INPO-20XXXXX).
5. **IMPORTANT:** After you have finalised the form and received your unique reference number, click on the following link (while still being logged into the InvestEU Portal): [https://ec.europa.eu/investeu-portal/myportal/event/EAIS\\_23](https://ec.europa.eu/investeu-portal/myportal/event/EAIS_23)

**Clicking on this link signs you up for the EAIS 2023 event specifically - once you have done so, you should receive another email with the acknowledgment of registration - this will be your final confirmation that your application to pitch at EAIS 2023 has been successfully submitted.**

However, the easiest ways are either adding your mobile phone in your EU Login Account settings (EU Login) to receive a code by SMS or by simply using the EU Login app available in all smartphone app stores.
