## **Startup Application Instructions**

If you wish to be selected to pitch at European Angel Investment Summit (EAIS) 2024 please submit your investment project on the InvestEU Portal by following the instructions below:

## Visit https://ec.europa.eu/investeuportal/desktop/en/index.html

Click "Add your project"



- 1. Log in\* or create a new profile\*\*, providing details about your organisation. Your organization may be based in any country, however, your project must be based in the European Union.
- 2. Upload documents establishing the company's legal entity (e.g. registration extract) and any other relevant documents (e.g. recent audited financial statements, activity reports) detailing the activity of the company.
- 3. Complete information about your "project". Here as well you can submit information about your startup in more detail. Please make sure to include details about the investment round you are raising.
- 4. Please mention any angel investors or angel networks you've received investment from. (Project description > Project financing > Financing details > Open text field)
- 5. Once you complete all 3 parts of the form (profile organisation –project), you should receive an email confirmation indicating your unique reference number (format: INPO-20XXXXX).
- 6. **IMPORTANT**: After you have finalised the form and received your unique reference number, click on the following link (while still being logged into the InvestEU Portal):

Without this step your application will not be considered for EAIS 2024!

Clicking on this link signs you up for the EAIS 2024 event specifically - once you have done so, you should receive another email with the acknowledgment of registration - this will be your final confirmation that your application to pitch at EAIS has been successfully submitted.

\*In order to log in, you need to use two-factor authentication. With two-factor authentication, in addition to your password, you will also need a second form of verification to log in. However, the easiest ways are either adding your mobile phone in your EU Login Account settings (EU Login) to receive a code by SMS or by simply using the EU Login app available in all smartphone app stores.
